KENTECH and Tenstreet have enhanced our integrated ordering solution - in addition to the extensive background screening services already offered, employers can now order pre-employment drug tests, physical examinations and alcohol screening through Tenstreet's Pulse MD (a paperless registration system facilitated by a smart device).

Employers will have access to more than 10,000 electronically enabled collection sites, 5,000+ electronically enabled clinics, as well as thousands of clinics for non-electronically served areas. KENTECH's board-certified Medical Review Officers help ensure test results are reviewed to determine permissible use of controlled substances and to provide alerts if any safety concerns or additional testing are needed.

How does it work?

The Pulse MD integration with KENTECH will save employers time and effort by streamlining the drug and alcohol screening process. Employers will simply access Pulse MD in the Tenstreet dashboard, order their preferred testing or exam services, and choose an appropriate date and clinic location.

Once scheduled, the driver will receive a notification in the Driver Pulse application or an email will be sent if the driver does not have the application downloaded. The driver notification will include all pertinent information about the scheduled test or exam, including a digital barcode with collection site details, such as: clinic location, open hours, and whether truck parking is available.
